

ORDINANCE NO. _____

AN ORDINANCE ALLOWING A SPECIAL USE FOR AN OUTDOOR ARTS AND CRAFTS MARKET IN A C-6 ZONE FOR CERTAIN REAL PROPERTY LOCATED AT 510 MAIN STREET IN THE CITY OF NORTH LITTLE ROCK, ARKANSAS; DECLARING AN EMERGENCY; AND FOR OTHER PURPOSES.

WHEREAS, application was duly made by Argenta Downtown Council, 707 Main Street, North Little Rock, AR 72114, seeking a special use of said land to allow an outdoor arts and crafts market, which application was duly considered and approved (6 affirmative votes; 2 absent; 1 abstain) by the North Little Rock Planning Commission at a regularly scheduled meeting thereof, held on May 12, 2009.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF NORTH LITTLE ROCK, ARKANSAS:

SECTION 1: That a special use is hereby granted to allow an outdoor arts and crafts market in a C-6 zone for the subject real property located at 510 Main Street in the City of North Little Rock, being more particularly described as:

South 50 feet of Lot B, P and R Properties Addition to the City of North Little Rock, Pulaski County, Arkansas. (See Exhibits "A" and "B" attached hereto.)

SECTION 2: That this special use shall be subject to the conditions listed below:

- a) Applicant must meet all applicable Federal, State, County and City requirements.
- b) Similar style tents with a white, blue or tan canopy are to be provided by vendor or applicant.
- c) All tables are to be skirted.
- d) Flags, banners and decorative items are to be allowed on sales days.
- e) Any permanent signs to meet the requirements of the Sign Ordinance.
- f) Trash is to be cleaned off the lot after each sales day.
- g) Hours of operation are 5 AM to 9 PM, Tuesdays, Saturdays and Special Events.
- h) Limited to maximum of 40 units/vendors.
- i) Location of units/vendors to be determined by the Market Manager.
- j) Business license to be issued after confirmation by Planning Department Staff that requirements imposed by City Council have been met.

SECTION 3: That all ordinances or parts of ordinances in conflict herewith are hereby repealed to the extent of the conflict.

SECTION 4: That the provisions of this Ordinance are hereby declared to be severable and if any section, phrase or provision shall be declared or held invalid, such invalidity shall not affect the remainder of the sections, phrases or provisions.

SECTION 5: It is hereby found and determined that the special use of the above-described lands as provided for herein is immediately necessary in order to insure the proper and orderly growth of this land and the proper and orderly growth of the City of North Little Rock, Arkansas, and being necessary for the immediate preservation of the public health, safety and welfare, THEREFORE, an emergency is hereby declared to exist and this Ordinance shall be in full force and effect from and after its passage and approval.
